If your business is a corporation, limited partnership, limited liability company or limited liability partnership please provide the Federal ID number and Kansas Secretary of State's Business Entity ID number. Information about registering a business with the Kansas Secretary of State is available online at www.kssos.org or by phone at (785) 296-4564. The business must be registered with the Kansas Secretary of State and in good standing.

The processing time for completed applications is generally 5-7 business days. Applications are processed in the order they are received and may take up to 30 days during peak renewal times. Submitting an incomplete application will delay processing. If you do not receive an incomplete application notice or your license within 30 days please contact our office.

All sections of this application are required to be completed. If an application is incomplete, you will be notified and will have 30 days to submit the additional information. A complete application includes:

1. A completed Lead Activity Firm Application with no sections left blank
2. Payment of the non-refundable application fee as specified in K.A.R. 28-72-3, unless the firm is exempt under K.A.R. 28-72-10(b)(2)(B). Firms exempt are federally recognized Indian tribes, local government or nonprofit organizations. A letter of determination issued by the IRS must accompany the application.
