Please print clearly or type all the information requested on the application.

If your business is a corporation, limited partnership, limited liability company or limited liability partnership please provide the Federal ID Number and Kansas Secretary of State's Business Entity ID Number. Information about registering a business with the Kansas Secretary of State is available online at [www.kssos.org](http://www.kssos.org) or by phone at (785) 296-4564. The business must be registered with the Kansas Secretary of State and in good standing.

The processing time for completed applications is generally 5-7 business days. Applications are processed in the order they are received and may take up to 30 days during peak renewal times. Submitting an incomplete application will delay processing. If you do not receive an incomplete application notice or your license within 30 days please contact our office.

A KDHE Licensed Lead-Safe Renovator logo is available to those companies who are properly licensed to conduct activities specified in K.A.R. 28-72-2 and K.A.R. 28-72-51 through K.A.R. 28-72-54. If you would like to request a copy of the logo, please send an email request to [lead@kdheks.gov](mailto:lead@kdheks.gov). You may use the logo to identify your firm as an RRP licensed firm in brochures, advertisements, websites, proposals, bills, signs, uniforms, vehicles and other materials promoting or identifying your firm. You may not use the logo in any manner that would imply KDHE endorsement of a company, provide the logo or allow a firm that is not RRP licensed (including your subcontractors) to use the logo provided only to you.

All sections of this application are required to be completed. If an application is incomplete, you will be notified and will have 30 days to submit the additional information.
